Project Updates

The Rosehill to Harden Pipeline Replacement is making great progress with contractors TCM Civil Pty Ltd commencing the works in early January.

The project will consist of replacing 11km of ageing 375mm mild steel pipes that was constructed in the mid 1930's to 500mm and 450mm ductile iron cement lined pipe.

The upgrade will provide many benefits to the surrounding communities including:

- reduced service disruptions and breakages
- reduction of water loss from pipe breakages
- efficient operation of the system
- increased water supply and capacity to cater for future growth

Also progressing on schedule is the Old Jugiong Water Treatment Plant Demolition Project, which commenced in February.

This project is being completed by AGH Demolition and Asbestos Removal Pty Ltd and includes the demolition of the old filtration plant, sedimentation tanks and associated infrastructure of the old plant site.

The project will provide benefits such as:

- additional space for future construction of new water treatment infrastructure
- removal of buildings that contain hazardous material and asbestos
- rehabilitation of the natural habitat and erosion protection near the Murrumbidgee River

The original water treatment plant was constructed in the early 1930s and was decommissioned in 1991, when the current water treatment plant was officially opened.

The demolition is expected to be completed by mid-June 2021.

Pump Station upgrades and replacements

It's been a busy couple of months for our mechanical and electrical staff upgrading and replacing a number of pumps throughout the scheme.

The replacement of two pumps at the Ganmain pump station was a combined effort from the mechanical, electrical, distribution and engineering teams. The new system can pump up to 9L/s if required and the replacement will ensure a more reliable water supply for Matong and Grong Grong customers.

The Weethalle and North Weethalle pump stations have also undergone an upgrade as part of Goldenfields Water's asset renewal program. These upgrades will ensure a continued water supply reliability for customers.



Junee Mains Upgrade

In February the southern distribution team replaced approximately eighty metres of mains near Cox St, adjacent to Memorial Park, as part of the project's stage 1 upgrade.

Working with Junee Shire Council and Transport for NSW, the southern distribution team bypassed the existing main and replaced it with 200mm pipe over a one week duration.

Stage 2 of the upgrade will take place in the coming month and will involve laying additional pipeline.

This upgrade will significantly help reduce bursts, especially during peak demand periods.






Board Members on Tour

In early March the Goldenfields Water Board Members took a tour of the Rosehill Project and Old Jugiong Water Treatment Plant Demolition Project.

The Board Members spent the day meeting with Rosehill contractors and enjoyed a walk-through of the site, followed by a presentation about the demolition works at the Jugiong Water Treatment Plant.
