

9.3.2 GWCC500 UPDATE (G30608005)

Funding:

GWCC has signed a Project Service Agreement with Riverina Local Land Services, guaranteeing funding of \$100,000 for the first stage of the project.

The NSW Environmental Trust, Office of the Environment and Heritage announced that the GWCC500 project has been award an Environmental Education Grant for \$58,600 over 2 years.

Workshops:

The first Native Seed Collection workshops will be held at schools in Beckom, Ardlethan, Marrar and Murrumburrah from the 9th of December. Workshops will be delivered in conjunction with the Riverina Local Land Services and will include seed collecting, processing and storage. Seed collected from the workshops will be used for corridor revegetation.

Landholder Participation:

Expressions of Interest from 63 landholders have been received for participation in the GWCC500 project. Riverina Local Land Services will assess applications for funding eligibility towards revegetation and habitat protection in 2015.

9.3.3 OURA BORE 2 REPLACEMENT PROJECT (G95253005)

- 14/142 **RESOLVED** on the motion of Crs Palmer and Manchester that:
 - 1. Council cease the project and remove from program in its current form.
 - 2. Request a quotation from Paul Milne Drilling as a variation to the current contract to retrieve s/s casing and screen, plug bore, and reinstate site.
 - 3. Compare options of upgrading existing bore 4 and 6 to submersible pumps with variable speed drives giving better efficiencies and reliability against investigations and landowner negotiations for a new bore site.

Report Prepared by Engineering Officer

Drilling works have been completed for the Oura Bore 2 replacement project with a 610 mm dia. stainless steel casing and screen inserted. Yield/pump testing was conducted over a 48hr period and identified maximum flow rates lower than anticipated at 120 L/sec. The existing bores 6 and 4 in the area pump at 160 L/sec which was the target, and soil sampling of the test bore indicated it was achievable showing a larger than expected water bearing zone.

Expenditure to date is \$299,806 with an estimated \$315,000 required to install pump and connection pipework, and upgrade electrical infrastructure. Upon spending the money the new bore would not sustain even winter flows.

The stainless steel casing and screen could be removed and used at a more suitable location pending further investigations.

This would allow the County Councils to provide services freely in that JO and adjacent JO's that have constituent GWCC members. The JO will also have functions to accept tenders etc if given appropriate powers. This was not universally supported.

Injury reporting is also below par at 60% reported in 2 days compared to 73% OLG average.

WHS self audits at 99.4% were well above StateCover average of 75% and a pleasing result.
